FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS



Q1. WHERE IS EPE VILLE?

EPE VILLE is located in IGBOOYE EPE, Lagos state sharing boundaries with St Augustine University, Epe Resort, Epe Food Logistics Hub, Alaro City, Gold Fish Junction. Applicants or their representatives are advised to inspect the site, subsequent to confirmation of appointments made at PWAN ZENITH office or with the designated sales representative. Free inspections hold Mondays to Saturdays. Take offtime is 10am.
